Karnataka State Tourism Development Corporation Ltd (KSTDC) invites Sealed Tenders as mentioned hereunder in the attached prescribed format from reputed Taxi Operators to provide taxi services as and when needed for various package tours and tourist on Rate Contract Basis.

Interested parties may submit their bids in sealed envelopes duly super-scribed as “**TENDER FOR EMPANELMENT OF TAXI OPERATORS**”. The Bidder/Tenderer is requested to self attest all the papers comprising the Bid application and all the Annexures attached.

The Bidder/Tenderer is requested to quote rates in the Bid application keeping in view of the terms and conditions of this Tender Document and the tender is liable to be rejected, if any changes in the terms and conditions is proposed. The Bidder/Tenderer has to submit **Earnest Money Deposit (EMD)** of Rs.50,000/- (Rupees Fifty Thousand Only) through Demand Draft only (payment by cheque or any other mode is not acceptable) in favour of “**Managing Director, KSTDC**” payable at Bangalore. Tenders without the Earnest Money Deposit (Demand Draft Only) will be deemed rejected.

Interested Taxi Operators can obtain the detailed Tender Document, containing detailed Terms and Conditions, Eligibility Criteria and Annexures to be attached with bids, against a written request on their own letter head from the Office of Manager (Tour), KSTDC, Bangalore along with Cash payment / submission of a **non-refundable Demand Draft** only of Rs.500/-drawn on any Nationalized / Scheduled Bank in favour of “**Managing Director, KSTDC**” payable at Bangalore on all working days (Monday to Friday) between 10.00 A.M. to 3.30 P.M. ELIGIBILITY CRITERIA

1. The Bidder/Tenderer should be based in Karnataka and operating their business from Karnataka. **Attach photo-copy of proof.**
2. The Bidder/Tenderer should have a minimum experience of 5 Years as Taxi Operators. **Attach photo-copy of proof.**
3. The Bidder/Tenderer must own a fleet of atleast 50 (Fifty) or more taxis in the State with valid All India Permit.
4. The Bidder/Tenderer should have rendered satisfactory taxi services to at least two Public Sector Company / Public Sector Bank / Central or State Government Undertaking / Autonomous Institute or any Private Corporate Establishment of repute. **Attach Certificate of Experience and Satisfactory Completion of work awarded from concerned Establishments / Companies.**
5. The Bidder/Tenderer should furnish List of Clients to whom satisfactory taxi services are given during the last three financial years i.e. 2015-16, 2016-17 and 2017-18. Attach Certificates from concerned Clients/Companies.
6. The Bidder/Tenderer should have minimum average annual turn-over of Rs. 20 Lakhs from the Taxi business.
7. The Tenders from Individual / Firm / Organization including its Partners / Shareholders / Directors, who have been blacklisted / prosecuted by any departments / statutory bodies in any State or by any Court of Law, shall not be entertained.

TERMS & CONDITIONS AND INSTRUCTIONS FOR BIDDERS

1. The rates quoted by the Bidder/Tenderer shall be valid for a period of two years from the date of empanelment of Taxi Operator.
2. The Bidder/Tenderer is required to clearly indicate their name, address and contact details on the sealed envelopes.
3. The Bid application should be sealed and duly super-scribed as **“TENDER FOR EMPANELMENT OF TAXI OPERATORS”** and Addressed to Manager (Tours), KSTDC Corporate office, BMTC-TTMC Building, Yeshwanthapur, Bangalore-560022 on or before 16.01.2019.
4. The Tenderer/Bidder has to submit Earnest Money Deposit (EMD) of Rs. 50,000/- through Demand Draft only (**payment through cheque or any other mode is not acceptable**) in favour of “Managing Director, KSTDC” payable at Bengaluru along with the Bid application. Tenders without the Earnest Money Deposit will be deemed rejected.
5. The Earnest Money shall be forfeited if the Tenderer withdraws his Tender during the period of Tender Validity. The Earnest Money will also be forfeited if in the case of the successful Tenderer, the Tenderer fails to comply with all the terms and conditions of the Tender Document.
6. The Bidder/Tenderer are hereby informed that the Company will arrange inspection of their Office Premises and infra-structure facilities of Tenderer/Bidder through a Committee of Officials of the Company and/or through an Investigator appointed for the purpose, to verify the existence and to assess the competence of Bidders/Tenderers in providing satisfactory and efficient services required in the Tender Document. The report shall be taken into account for the purpose of assessing the competence of Bidders/Tenderers. The decision of the KSTDC in this regard shall be final and binding on the Bidders/Tenderers.
7. All the copies of the documents mentioned in the Eligibility Criteria, Annexures I to IV and other necessary documents are required to be attached with the Bid application.
8. Earnest Money Deposit of unsuccessful Tenderer/Bidders will be refunded within 30 days from the date of opening of tenders except of the qualified bidder.
9. On Empanelment of Bidder/Tenderer as Taxi Operator for providing taxi services, the Earnest Money deposited by them with the Bid application shall be retained as Security Deposit with the Company.

10. Unsealed tenders will not be accepted. The tender received in any manner other than prescribed above shall be summarily rejected. Any tender received after the scheduled date and time shall not be considered. The Company will not accept any responsibility for the tender lost in transit or delivered elsewhere.
11. Tender applications will be opened on the scheduled date and time given in the “Notice Inviting Tender”. The Bids will be evaluated on the basis of documents/information furnished and eligibility criteria. The decision of the Managing Director, KSTDC in this regard shall be final and binding on the Tenderers.
12. All over-writings/corrections should be duly signed by the Tenderer/Bidder.
13. Each Tenderer/Bidder will submit only one tender either by himself or as a partner in joint venture/firm/company.
14. Canvassing or offer of an advantage or any other inducement by any person with a view to influencing acceptance of a bid will be an offence under Laws of Land. Such action will result in the rejection of bid, in addition to other punitive measures.
15. Tenders/Bids must be submitted to the Manager (Tour), KSTDC, Corporate office, BMTC-TTMC Building, Yeshwanthapur, Bangalore by the date and time stipulated in the Notice Inviting Tender in a sealed cover and put inside the Box kept for the Tender. The Company may, at its discretion, extend the deadline for submission of Tenders/Bids in which case all rights and obligations of the Company and the Tenderer/Bidder will be the same. The information thereof will be available on the Company's Website and Notice thereof will not be published in any newspaper. All Tenderers/Bidders are, therefore, advised to visit the website regularly for updates.
16. The Contract with the Bidder/Tenderer can be cancelled by the KSTDC by giving one month's notice in writing without assigning any reason, whatsoever.
17. In case the Bidder/Tenderer desires to cancel the contract, he is required to give one month notice in writing to the KSTDC.
18. Managing Director, KSTDC, Bengaluru reserves the right to reject/cancel any or all the tenders without assigning any reason, whatsoever.

SCOPE OF SERVICE AND PAYMENT TERMS

1. The rates quoted by the Bidder/Tenderer in the Bid for providing taxi services will be valid for atleast two years from the date of Empanelment of Bidder / Tenderer. No revision in rates shall be allowed during the Rate Contract Period.
2. The rates quoted by the Bidder/Tenderer should be inclusive of driver charges, fuel and all maintenance costs.
3. All taxes, toll tax and parking charges incurred by the Bidder/Tenderer during the course of providing taxi services/journey will be reimbursed by the Company on actual basis. These charges are to be paid by the driver of Bidder/Tenderer on duty and shall be claimed by the Bidder/Tenderer along with the bill on completion of tour/trip.
4. The taxi used for Outstation Trips, the minimum average running limit of taxi will be 250 Kms. per day.
5. The next package rates will be applicable only if both the time limit and Kilometer limit of lower package exceeds.
6. The Taxies should be in a perfectly maintained condition with presentable look and should not be more than Four years old.
7. The Bidder/Tenderer will submit/raise bills soon after completion of the Tours/trips along with the User / Tourist Certification Slip certifying the KMs reading and time of usage. The bills shall be settled within 15 days from the date of receipt of bill by the Company. The time will be rounded off to hour.
8. The driver driving the Taxi must have a valid driving license and the Company would have no liability, whatsoever. Also taxies must have all India permits etc. as per relevant R.T.O. Rules and regulations and insured all the time under M.V. Act.
9. In case of accident, the KSTDC would have no liability, whatsoever.
10. The Taxies sent should be insured comprehensively with maximum coverage for all passengers according to the carrying capacity of the vehicle.
11. The time consumed from garage to reporting place should be actual, subject to a maximum of half an hour.

12. The drivers of Taxi sent must be provided mobile phones and Uniforms. The Vehicle/Taxi Number and Mobile Phone Number of Driver be conveyed through SMS or call on the Cell Phone of both the User/tourist and the authorized departmental official well in advance for their information.
13. The Drivers deputed for duty will maintain his behavior as becoming of Gentleman and would extend help in bringing the goods / suitcase of the User/Tourists loading / unloading, if need be.
14. For local running night charges are not payable.
15. The behavior of the driver should be polite, cordial, obedient and never convicted by any Law Agencies. In case of any misbehavior, in addition to taking legal action, the Tenderer will be penalized for the same and the decision of the Competent Authority of the company in this regard shall be final and binding on the Tenderer.
16. The driver, in addition to safe driving of the car, would receive/a lighten the occupants in a very respectful manner and would obey the instructions of the occupants.
17. On receipt of rates from the Bidders/Tenderers, the Company's authorized officials may visit the office/garage of the Bidder/Tenderer for inspection of fleet of cars available with them. The lowest rates received from eligible Bidder/Tenderer for each type of vehicle and for each slab would be offered to all eligible Bidders/Tenderers for their consideration and acceptance. The Bidders/Tenderers who are ready to provide taxi services on these rates and accept the rates in writing would be empanelled as Taxi Operators by the company for providing taxi services.
18. The empanelment will be confirmed by the Company in writing only on receipt of confirmation from the eligible Bidders/Tenderers that the rates offered are acceptable to them.
19. The rates offered or agreed would be valid for atleast a period of two years from the date of acceptance by the eligible Bidders / Tenderers.
20. The bidder shall quote the rates for both SUV (like Innova Crysta) and Sedan Cars (like Toyota Etios, Swift D'zire etc). The Bidder quoting the lowest in each of the category shall be empanelled separately.
