The Managing Director, Karnataka State Tourism Development Corporation Ltd (KSTDC) invites the bids for sale of Old vehicles parked at KSTDC's Workshop, Yeshwanthpur unit as shown in the Annexure II. Sale will be conducted by way of calling Box Tender. The highest rates received will be considered for acceptance. The detailed terms and conditions are stipulated below.

The Bidder/Tenderer is requested to quote rates in the Bid application keeping in view of the terms and conditions of this Tender Document and the tender is liable to be rejected, if any changes in the terms and conditions are proposed.

**GENERAL TERMS & CONDITIONS:**

1. The bidder/tenderer is required to clearly indicate their name, address and contact details on the sealed envelopes.
2. The bid application should be sealed and super-scribed as "TENDER FOR SALE OF OLD VEHICLES" and addressed to Manager (Transport), KSTDC, Corporate Office, BMTC-TTMC Bus Stand, Yeshwanthpur, Bangalore-560022.
3. **EMD:** The Bidder/Tenderer has to submit **Earnest Money Deposit (EMD)** of Rs.5,000/- (Rupees Five Thousand Only) per vehicle through Demand Draft only (payment by cheque or any other mode is not acceptable) in favour of "**Managing Director, KSTDC**" payable at Bangalore. Tenders without the Earnest Money Deposit (Demand Draft Only) will be deemed rejected.
4. Interested parties may submit their bids in sealed envelopes duly super-scribed as "**Tender for sale of old vehicles**" **on or before 16.02.2019** at 15.00 HRS at Corporate Office by addressing Manager (Transport), KSTDC, Corporate Office, BMTC-TTMC Building, Yeshwanthpur, Bengaluru-560022 along with tender document fee of Rs. 500/- (non refundable) only through **Demand Draft** drawn on any Nationalized / Scheduled Bank in favour of "**Managing Director, KSTDC**" payable at Bangalore on all working days (Monday to Friday) between 10.00 A.M. to 3.30 P.M. The Bidder/Tenderer is requested to self attest all the papers comprising the Bid application and Annexure attached.
5. Bidders have to access details and tender application on the KSTDC website i.e. [www.kstdc.co](http://www.kstdc.co) and fill them and submit the completed tender document into tender box. The sale of old vehicles is on the basis on '*as is where is condition*' and CAVEAT EMPTOR' principle.
6. Intending bidder may be inspected the vehicles at KSTDC Workshop, behind Govt. Soap Factory, Industrial Area, Opp. TVS Centre, Yeshwanthpur, Bengaluru-560022 before 16.02.2019 at 12.00 PM.

7. Bidders/Contractors shall attach the scanned copies of PAN Card and Address Proof / Identification Proof pertaining to their pre-qualification.
8. No person except the holder of power of attorney shall be entitled to bid for another person. Participants, who intend to bid on behalf of another firm/person, should be a holder of power of attorney duly executed on a stamp paper of requisite value in his favour authorizing him to do so. Bids submitted jointly by more than one person shall not be accepted unless such persons are members of a registered company or Firm and the bid submitted is on behalf of such Company/Firm.
9. Bids from persons who are black-listed, convicted, minors, who have failed to pay Government dues or who are insolvent will not be accepted and the EMD will be forfeited.
10. The bidders shall at the time of submitting the bids, furnish his/her specific address and Mobile/Land Line Phone number to which all communication could be sent. KSTDC will not be responsible for the consequences (if any) due to communication sent to the address is not received by them. The responsibility to receive all communications shall fully rest with the bidder only.
11. The bidders should quote their highest price, exclusive of taxes (GST) for which bid is offered in Annexure-I. In addition to payment of the tender amount, successful bidders shall also be liable to pay all statutory taxes, cess, fee, levy (GST) etc., as per applicable statutes. The legal charges for conveyance, stamp duty and registration or any other charges as are applicable will be to borne by the purchaser.
12. The acceptance of the bid will be communicated to the successful bidder as early as possible, but not later than 30 (Thirty) days from the last date of open of the bid by post. If any bidder withdraws his offer before the expiry of this period, the Earnest Money Deposit (EMD) will be forfeited to the Corporation.
13. If more than one bidder offers the same rate which is highest for the particular lot, the Managing Director, KSTDC reserves the right to award the lot after calling for revised open offer from among them.
14. Earnest Money Deposit (EMD) of the unsuccessful bidders will be returned to them as early as possible after confirmation of the sale.
15. The successful bidders shall have to shift the vehicles in respect of which sale are confirmed within 7 (seven) days of confirmation of sale. Failure to do so, within the said specified period would attract ground rent of Rs. 250/- (Rupees Two Hundred Fifty Only) per day. In any case, the successful bidders shall shift within 90 days of confirmation of sale otherwise they are liable to forfeit the amounts paid.

16. The successful bidder, as soon as his offer is confirmed and intimated, shall do full payment (inclusive of GST) of the bid amount of vehicle within 10 (ten) days from the date of confirmation. The amount should be paid in demand draft in favour of “Managing Director, Karnataka State Tourism Development Corporation Ltd”, payable at Bangalore. Non-payment of the bid amount after acceptance of the bid by KSTDC will result in rejection of the bid and forfeiture of EMD, without any notice. KSTDC reserves the right to re-tender the sale and the defaulting bidders, shall have no claim over this.
17. Bidders are advised to make themselves conversant with the conditions of the vehicle as well as box tender bid before making their offers. No plea of ignorance of any of the conditions will be entertained at a later date. The bidders are advised to seek clarifications of doubts, if any, before submission of their offers.
18. The acceptance of bid is subject to confirmation by the Managing Director, KSTDC, who may confirm or reject all or any bids including the highest bid without assigning any reasons. He reserves the right to alter the conditions of sale or postpone the bid.
19. Corrigendum/ Modification/ correction, if any will be published in the website only.
20. All kinds of legal proceedings in any matter arising out of the Contract shall be subject to the jurisdiction of the appropriate legal court at Bangalore.
21. Any other details and other information can be obtained during office hours.
22. The bidder must sign each and every page of the General Terms & Conditions, Special Terms & Conditions and schedules to the tender which form an integral part of the Tender.
